

## Tele-Consult Disclaimer

- ✓ Go to the nearest emergency room if you believe you are experiencing a medical emergency and if you suspect you have a COVID 19 medical emergency contact the Nigeria Center for Disease Control.
- ✓ You are agreeing to have a Tele-Consult consultation.
- ✓ Tele-Consult is the practice of medicine using electronic communications technologies.
- ✓ Tele-Consult consultation services are provided by Murtala Muhammed Foundation Partners
- ✓ When you use these Tele-Consult consultation services, you will enter into a provider-patient relationship and be treated by a provider who is licensed in Nigeria or in their country of residence.
- ✓ The providers, in exercising their professional judgment, reserve the right to deny care for any reason, including instances where provision of care would be medically or ethically inappropriate.
- ✓ Getting treatment through a Tele-Consult consultation offers certain expected benefits and has certain potential risks.
- ✓ Expected benefits include easier and quicker access to medical care, and the ability to access care from many locations. For example, you can initiate a remote examination from your home rather than having to wait to schedule one.
- ✓ Potential risks include the remote doctor not being able to fully resolve your issue over the phone, and lack of doctor access to your full medical records, which may, in rare instances, result in allergic reactions or other adverse drug interactions.
- ✓ You have other options for care. You can obtain care in a traditional in-person care setting, such as reaching out to your primary care doctor, contacting an urgent care facility or the National Center for Disease control.
- ✓ By agreeing to have a Tele-Consult consultation, you acknowledge that you have reviewed these benefits, risks, and alternatives, and you agree that you consent to a Tele-Consult consultation.
- ✓ You have the right to withdraw your consent at any time by ending this Tele-Consult consultation session.
- ✓ By agreeing to have a Tele-Consult consultation, you acknowledge you have received and read the **Notice of Privacy Practices** for Murtala Muhammed Foundation and its partners.
- ✓ You further authorize Murtala Muhammed Foundation and its partners to release your confidential information to each other and consulting providers.
